A firework display is planned for a date very near to bonfire night. Mr Hawes reported that a wild life site is planned on the Playing Field a barn owl box has been put up and several bird boxes are planned with a nature trail around the field. An application has gone in to the Tesco Bag Scheme for money to fund this and a fenced pond. Pallets have been put down ready to build bug houses.

- **County Councillor's Report** County Councillor Gordon Jones read to a written report attached to the minutes as **Appendix 19** in the minute book. County Councillor Jones remarked that this was his last Annual Report under the current administration with elections on 4 May and said what a privilege it has been to serve Bentley and work with the Parish Council. He was pleased to have financially supported from his Locality Budget both The Case and The Community Shop and was pleased with their successes which had made such a positive difference to the village. He had supported the Village School and the Village Hall and last month allocated the last of the Locality Budget to the Friends of Capel Library as they work to upgrade the Reception area. He ended his report by saying it had been a pleasure work with the village and hoped it will continue after May.
- **6.** <u>District Councillors' Reports</u> Apologies received from <u>District Councillor Hinton</u> who was unable to give an annual report as he hasn't been given any information from Babergh. A glossy magazine and video will be available in May.
- 7. <u>Signage Play Area –</u> The Chairman said this has been the subject of residents' concerns and he fully appreciated that speeding coming into the village is a big issue. This is on the agenda seeking opinions regarding the provision of children playing road signage which has been agreed will be funded by the Parish Council and might help reduce speeding round Case Lane area. This lack of signage was highlighted in the Annual Report of the Play Area Inspector. The cost of two signs will be in the region of £800-£1K.
- 9. Question and Answer Session Resident Wanted to know if there was a weight limit on the road to the Village as more and more lorries are coming through to get onto the A14. There is no weight restriction at present. Resident was concerned about the white lining which is very feint County Councillor Jones said he had recently raised the subject of white lining -Transport Minister due to visit South Suffolk stretch of A12 soon re Copdock Roundabout- which is due for modification- and Four Sisters.
