Public Session

County Councillor Jones-said it was good to be back working for the next four years. He stated that the Annual Meeting of the Council was only held last Thursday where cabinet members are put in place- he was pleased to say that he has the same responsibility as previously. Two new members in the cabinet have the responsibility for Ipswich and there is a new post for families and communities. SCC is effectively still in Purdah since March – this finishes next week and there are challenging times ahead. There will be a written report next month. County Councillor Jones was asked about SCC being in transition at the moment – he was told that Bentley PC had agreed to purchase signs for the Play Area and also informed of the e-mail from a resident asking for the 30 mph to be extended beyond Station Farm. Cllr Jones said that unless there has been any major change it is unlikely to get through the panel and there is a long legal process however he asked the Clerk to forward the e-mail from the resident to him.

Resident – informed the meeting that a 30 mph sign had been knocked over in Capel Road. Clerk to Notify SCC.

- 7. Report by Exception - Tree Warden/Footpath Warden - Tree Warden - Read to a written report – **Appendix 1** in the minute book. He reported that trees along Case Lane footpath have been in reduced in height so they do not impede overhead wires – the Holly tree by the War Memorial is touching the overhead wires and has not yet been reduced in height and it is that time of year to watch out for Ash-Dieback disease which is spreading rapidly and also to look out for Acute Oak decline disease. Capel Library: Mr Hawes thanked Bentley Parish Council on behalf of the Friends of Capel Library for the £200 donation which will be put towards refurbishment of the library reception area. The 100 Club membership is now 85 - the Community Cinema is very popular with 61 attending the May film -the next film "Lion" will be shown on 20 June. FoCL will have a marquee at Capel Fund Day on 10 June and second hand books in good condition will be on sale at 30p each as well as other items - half the money raised will add to FoCL funds and the remaining half helps fund Capel Fun Day 2018. Bentley Long Barn - There is no further news on the Long Barn other than it is up for sale for £250K and if it is taken on as a Community Asset this amount will have to be raised. Footpath Warden - Cllr Wheals announced the next walk is on Saturday at 6pm - Harkstead Creek.

Cost of tickets would be £4 adult £3 children if 400 people attended it would almost cover the cost. It was proposed that the Parish Council donate £500 towards the firework display based on a budget of £2K. Any shortfall could be made up from the Fun Day account.

The Council have agreed a procedure that i) Site details are confidential and cannot be discussed in an open meeting ii) Hastoe have been appointed to find the site and landowner prepared to sell iii) Hastoe have discussed with

Planners and selected a site - iv) they now have to talk to the land owner - v) Hastoe will then submit a Planning Application for Parish Council to consider. We have delegated the process to Hastoe.

- Playing Fields Society A meeting was held before the Parish Council Meeting Jo Willis reported everything is on track for the Family Fun Day on 10 September but volunteers are needed. The grass cut has taken place and a metre has been left round the perimeter as asked for An acknowledgement has also been received from Tesco Bags regarding our application for funding. Firework display (28 October) was discussed (see above) Information is to be sought from Ipswich Borough Council regarding BMX ramp and wooden practice wall. Date of next meeting 7 September 2017.
