To discuss Supplementary Response from PC to accompany Church Road Development Report – Cllr Munday wanted Alison Farmer's Report to be submitted with supplementary representation from the Parish Council. Following a lengthy discussion it was proposed that a response be sent enclosing a list of the important points from the report, Alison Farmer's full report and AONB landscape assessment – as it was felt that the landscape assessment by the developers was incomplete in places.

Councillors were concerned about talk of a new school playing field and a pupil increase of 55-70 (although only 48% are from Bentley)- as a result of development in the village – this would mean another 80 houses to produce that number of children. He asked for a letter to go to County Councillor Jones as he has an interest in the car park - and the play area only has 5 years left on the lease – this needs to be increased asap. Cllr Munday reported that the SID pole positions had been completed with the help of Mr B Mawkes – this will be reported on at the September meeting.
