## MINUTES OF THE ANNUAL PARISH COUNCIL MEETING HELD AT BENTLEY VILLAGE HALL THURSDAY 9 MAY 2024 AT 7.30 PM

The outgoing Chairman Cllr Munday welcomed everyone to Bentley's Annual Parish Council Meeting and apologised for the slightly late start. The Clerk received no notification of anyone planning to film or record this meeting.

1. <u>To Elect Chairman for Forthcoming Year</u> – It was proposed that Cllr Munday be elected Chairman for the forthcoming year to continue her excellent service. Cllr Bamford said she had been a fantastic Chair over the last few years and the Clerk and Councillors agreed. There were no other nominations. Cllr Munday was willing to stand for one more year to see through issues for Bentley that were ongoing at the moment and that she felt responsible for seeing through. ## **Public Session**

**County Councillor Georgia Hall** had sent her written report which has been circulated to Councillors – **APPENDIX 1** in the minute book and on the website.

**District Councillor David Busby** had sent his written Annual Report which has been circulated to Councillors – **APPENDIX 2** in the minute book and on the website. He spoke about the four year term being beset by financial concerns – one of the issues being car parking fees which will be sorted out and will help to reduce the shortfall – Joint Local Plan – First Part- which in his opinion fails to protect that which is dear to us but over protects against other Housing developments. Locally there have been planning battles over solar farms and BDC will continue to have battles throughout the next three years. The second part of the JLP – allocation of sites is being worked on now – so if you have any sites in mind. Due to Covid there is a build -up of outstanding maintenance work on the Council House Portfolio which needs to be addressed. He thanked County Councillors Helen Davies and John Whyman for giving his parishes valuable support – he ended his report by telling the meeting that Babergh along with Mid Suffolk had won Council of the Year.

**Resident:** Told the meeting that he was driving back to Bentley from Capel and a lorry was parked on the left hand side of the road (on some of the pathway) – unfortunately he was blinded by the sun and hit the lorry – luckily not a great speed as his airbag didn't go off. He asked the Council if they could take it up. He was told that part of the road would come under Capel St Mary PC. He insisted that the PC should take it up as safety of residents is paramount. The Clerk will contact Capel Clerk and ask if they will contact Suffolk Highways about how the parking issue can be resolved.

To discuss Annual Playground Inspection Reports- Councillors had been issued with a copy 14. of the Inspection Reports. Work required was noted and will be acted upon. The Clerk told the meeting she had ordered the knobs for Springy Prancer last year – but they had not been forthcoming - she will chase. It was proposed that the report be accepted - cheque (£168) to be passed for payment at tonight's meeting.

- 15. Land for Nature Recovery/Copse – Following a meeting with Babergh on site Cllr Feltwell suggested that the PC put together a bid to try and get some money to employ tree surgeons and hire a chipper to start clearance of the land - get rid of the trees etc. Cllr Feltwell and Cllr Spicer will put together a bid.
- Affordable Housing Update CAS had suggested- 'Call for Sites' which would provide **16.** evidence of transparency by encouraging anyone to put forward a site for discussion. Cllr Munday felt we needed to give feedback on some of the inaccuracies in Hastoe's report before we do a call for sites at this stage. A discussion followed on houses already built in the village. Cllr Munday asked Councillors to feedback comments re the Void Report to the Clerk.

- **17.** Road Works/Flooding Cadent/Anglian Water Update It was agreed that we need feedback on the road and whether they can give us that information. A discussion followed on the various Broadband companies.
- **18. 20's Plenty Campaign Update -** The Motion needed to be sent to SCC The Clerk will contact County Councillor Georgia Hall to find out where to send it. No other information available as Cllr Jones is on holiday.

- 19. Traffic Calming/SID data/Weight Restriction Update Cllr Munday told the meeting she had met with Graeme Mateer Head of Transport Strategy, Growth, Highways & Infrastructure and had done a drive round Bentley roads pointing out the issues including restricted road width at the level crossing, Bentley Hall Road, Capel Road, the dangerous junction at Bergholt Road, the narrowness of the pavements and proximity of houses to the carriageway. He is now going to do a feasibility study (we seem to have SCC's interest at the moment). Cllr Munday has a meeting next week with Melanie Hall regarding traffic calming. We had been informed that additional slow marking and speed roundels will need to be funded by the Parish Council at a cost of £5,638 Georgia may be able to give a small amount from her Locality Budget. A specific response to County Councillor Hall's quote is required before a decision can be made.
- 20 <u>Collins Skiphire Lorry Watch SCC</u> Planning Officer has replied re the new planning application for extension to the quarry at Folly Farm that any vehicles leaving or entering that site should not be going through Bentley. SCC will need photographic evidence of what is going on in the village with registration numbers time and date of each vehicle so we need volunteers to get this evidence a discussion followed Cllr Wheals will go and see Billy Richmont and Cllr Thomas will lead a group to get photographic evidence.
- 21. Changes to Procurement Thresholds Standing Orders (Section 28) & Financial Regulations (Section 11) The Clerk told the meeting that the new Model Financial Orders had just been issued by SALC but can't be used at this time—this item will be deferred until the June meeting.
- **22.** Playing Field Society Date of Next Meeting Before the July PC meeting. The Clerk had contacted Maritime about golf on the Playing Field. Apparently most public fields ban golf because it's dangerous and it causes a lot of damage to the ground. Cllr Bamford said the Play Area was now overgrown and the litter bin on the field is overflowing. The PTA had asked permission to put up a board advertising the School Fete it was agreed that could go ahead. The school notice board needs refurbishing.
- **Parish Infrastructure Investment Plan** This needs to be looked at very carefully we have had a response back from SCC about renewing the roundels etc and we can use CIL money if we have to pay.
