MINUTES OF THE PARISH COUNCIL MEETING HELD ON AT BENTLEY VILLAGE HALL ON -THURSDAY 3 APRIL 2025 AT 7.30 PM

Cllr Munday welcomed everyone to the meeting. The Clerk had received notification that a resident wished to record the meeting but has cancelled so no-one was planning to film or record this meeting.

Cllr Munday told Councillors that some Parish Councils ask for a reason for absence from Councillors who are unable to attend a meeting so the Council can accept the apologies if there is a valid reason for absence .Being a Councillor is a responsible position and if a Councillor is going to be absent the Council need to know that there is a genuine reason for that absence. The Clerk confirmed if a Councillor fails to turn up for a meeting six months in a row –they are no longer a Councillor. However, if apologies have been accepted then the six month rule starts again. This will be an agenda item at the May meeting.

SCC are going to do work on dropped drain outside The Coral and the potholes on the bridge by Little Dodnash - Oakleigh Update - Enforcement Officer carried out a site visit and noted the alleged works to the roof and building, subsequently the developer has been contacted making them aware of the need to act accordingly to apply for permission relating to demolition, or to carry out remediation. Public Session

District Councillor D Busby - Briefing Notes for Town & Parish Councils had been received and circulated to Councillors - **APPENDIX 1** in the minute book and on the website. He spoke about Brockley Wood - no news – it's in the hands of the BDC Legal Team. Joint Local Plan – housing allocations for Bentley is 140 over a 20 year period. This is not a firm figure and we will have to see how it develops. Whatever work is done will be adopted by the Unitary Council – Devolution and Local Government.

DC/25/01493 Windy Farm, Capel Road

Application for a Lawful Development Certificate for an Existing Use or Operation or Activity including those in breach of a Planning Condition. Town & Country Planning Act 1990 (As amended) – Confirmation of use of annexe/outbuilding as a separate dwelling

Applicant was re-applying following refusal by Babergh – it was proposed not to comment on this application. **NO COMMENT**

- NB: Noticed on District Cllr Helen Davies List application for 13 West Mill Green As Clerk hadn't received any notification from Babergh she e-mailed and was told that this type of application is not one which we they are required to consult third parties apart from neighbouring properties that share a boundary with the application site This is because the applicant is seeking confirmation that their proposal is permitted development under the prior approval scheme for a larger home extension. The application details can still be viewed on our website and there is nothing to stop the Parish Council from making comments if they so wish.
- c) To discuss SCC PROW's response re DC/24/05240 SCC are proposing if Babergh Planning approve the Fruit Farm application they want a condition put on the developers to pay for an upgrade to Footpath 55 to make it a bridleway. This is the footpath from Case Lane that joins up with Pond Hall Lane. There is no direct access from the site to this footpath. SCC want to make it into a bridleway for cyclists and horses this is very dangerous District Councillor Busby could see no reason for them doing this and charging £5K it should be a CIL request. After a long discussion it was proposed that a letter be sent directly to B#DC Planning with a copy to the the Public Right of Way Team saying this particular part of the Highways proposal is not appropriate.

e) Brockley Wood – To discuss re-Consultation Response – Cllr Munday explained that the reason why this was going out to re-consultation – late submission of revised plans by the applicant. She went on to explain about the siting of the washing and concrete crushing plant and the fact that we were trying to get the applicant to move it to another site within the quarry as it is only 300 metres from Bentley Old Hall. She also made the point that it had been said that the Parish Council was against the extraction of sand and gravel and this is not the case - it is making the case for improvements to the Lorry Route Management Plan to try to protect the village and the environment from the estimated 160 HGV lorries per day using the quarry. Bentley Parish Council is also objecting to the impact of the plant siting on the valued landscape and Old Hall – it was therefore proposed that the response be sent to SCC. The meeting was told that there is still three days for anyone to comment.

- 7. <u>Potential designation of a Bentley Historic Core Conservation Area Update</u> Mentioned by District Councillor Busby in Public Session above our Heritage Expert has responded to Babergh in full.
- 8. Report by Exception Tree Warden/Footpath Warden/Bentley Barn /Speedwatch Tree warden Nothing to report. Footpath Warden Two items Footpath 55 there were

two incidents at the farm – Farmer was hit by a tractor & pedestrian hit by a fork lift. **Bentley Long Barn** - Nothing to report- **Speedwatch**- There has been one session since my last report, this was held on Capel Road when eight vehicles were reported. The highest recorded speed was 40.

- 9. <u>Change of Bank and Online Banking Update -</u> Clerk reported that the Switch Form had been completed and sent to Lloyds. The new bank account is ready to go. Babergh Precept Team and VAT have been informed of the change of bank details.
- 10. To discuss purchase of Solar Panel for SID Quote for Solar Panel and mounting £434.23 VAT 86.85 = £521.08 SCC's cost for upgrading a normal post to a post capable of holding a solar SID will be £630 = £1,151.08 in total. After some discussion it was proposed that a post and solar panel be purchased. Clerk will inform Elan City.

- 11. To review Neighbourhood Plan The meeting was told that the drop in session was very successful with lots of comments and residents were informed why we are reviewing the plan now. We need to make sure we get the right number of houses in the places we want them built. Our Consultant is looking at the current NHP to see what policies need updating or changing. There are potential residential sites that have been submitted for consideration by Babergh and we may need to do a local call for sites. An independent consultant will review all sites for suitability. The revised draft of the NHP will then be reviewed by the community it will take some time but we have started the process. Cllrs Spicer & Campbell attended the meeting held by James Cartlidge and were amazed at the amount of Councils that did not have or want a Neighbourhood Plan James Cartlidge did mention East Bergholt NHP as an example of how not to do it or what happens if you don't have one. We have a very experienced NHP Consultant who will guide us through the process. We have a Government Grant to pay him it does not come out of PC precept. Cllr Munday thanked Cllrs Spicer and Campbell for attending the meeting on behalf of Bentley Parish Council.
- **12.** <u>Trimming Trees on Silver Leys Green Update</u> Andrew Graham Arboricultural Officer Babergh Visited Silver Leys and can see no reason at this time to undertake any works to trees under BDC ownership.
- 13. <u>To discuss grant re Lighthouse Women's Aid</u>—The Clerk read out a letter received from Lighthouse Women's Aid and after some discussion it was proposed that £100 be put in budget and donated at the Annual Parish Council Meeting in May.

To adopt changes to Financial Regulations – The Clerk told the meeting that following last month's meeting SALC had sent through changes to Procurement – items 5.4, 5.7 and 5.11 in the Financial Regulations. These changes have been made and Councillors have received the changes it was therefore proposed to adopt the changes.

- 17. Clearance of Land in the Copse Update Stage One clearance has been completed. Cllr Munday thanked Cllr Feltwell for the work he has done. Cllr Feltwell told the meeting this was started in May 2024 getting quotes to clear the land we put in a bid for funding in June and in August were told we had been unsuccessful. September obtained three quotes October nothing to report so taken off the agenda. On 24 January funding became available but work had to be completed by the end of March a bid was put in to do Stage One 53 tree stumps were taken out native trees were left. The Second Stage Contact School to find out what they would like. Suffolk Rural have agreed to oversee any proposals that come through the plan is to also get ideas from residents. Dedham Vale Tree Surgery did an amazing job and have the right equipment to do an industrial sized job. Working Group Cllrs Feltwell and Spicer.
- 18. Traffic Calming Weight Restriction Update We have finally got SCC to agree that both our village roads need Unsuitable for HGV signs. We need four signs at a cost of £6K County Councillor Georgia Hall has agreed to give £3K from her Locality Budget do we want to pay £3K? SCC have requested that the Brockley Wood applicant pay £20K for a weight restriction but it will take time about 18 months before these are in place. A discussion followed and it was proposed that we go ahead and that the £3K costs be met by CIL money. The signs will now be ordered.

Playing Field Society — Following discussion at the Playing Field Society meeting held at 7pm when it was agreed that Brantham Athletic be given a three month trial to use the facilities on a Thursday evening for the sum of £40 per month and to review further use at a meeting at the beginning of July. Clerk to draw up agreement with Conditions. It was also agreed to send letters to residents at The Oaks and Case Lane re the proposed use of the field. Cllr Feltwell recommended a sign — No football traffic. Cllr Bamford was prepared to make a telephone call to make Brantham Athletic aware there has been an issue with one of the residents.
