- c) **Brockley Wood** E-mail received informing us that the application has gone out for reconsultation again. This is as a result of the Conservation Area being designated. We have until 9 June to respond. They are long documents to look at the applicant seems to have taken note of Bentley Parish Council's objections the concrete crushing plant has now been taken out of the interim plan.
- **11.** <u>Bentley Historic Core Conservation Area Update This has now been designated and Babergh are going through all the processes. Residents need to be made aware that additional work needs to be done on the Management Plan.</u>
- **Report by Exception Tree Warden/Footpath Warden/Bentley Long Barn/Footpath Warden & Speedwatch Tree Warden** Still has a few woodland trees that will be used to gap up hedgerows or given free to anyone in the parish who has room to plant one or more. He gave an update on the Community Orchard and Bantu Farm (who removed trees they had planted in the Community Orchard) a notice will be put up on the water tank for use of CO only. He has visited the Copse several time to check flowering of the trees (oaks, walnut, Holly and cherry) all have flowered successfully. Half a black bag of litter was collected and put in the bin on the Playing Field. The next step with the copse is item 19 on tonight's agenda. Plane tree Lace bug disease is native to America but has spread around the world and first found in the UK in 2006. It has been seen more recently in 2024 on Plane trees in Central London. The bug can drop from trees and has been said to bite look online and you will see why it's called the lace bug. Please report it to The Forestry Commission is you see it. **Footpath Warden** –

Footpath 68 has been strimmed so people don't have to walk on the farm track. **Bentley Long Barn** – No further news - **Speedwatch** -One session on Good Friday – very busy – nearly every vehicle was over 30mph and two were doing 50 plus. – Stephen Williamson is trying to arrange sessions when he can and C Daldy is still liaising with the police. Cllr Wheals thanked Speedwatch volunteers.

- 13. <u>Change of Bank Update Clerk</u> told the meeting that the main account has been switched to Lloyds and Bentley Parish Council are now doing online banking. It looks as though the PC Tracker account has also been switched.
- **14.** To Review Neighbourhood Plan Update Cllr Munday told the meeting that we have received an e-mail from our Consultant today who has carried out the planned review and is preparing a report for the policies which need to be changed. We are also hoping our Consultant will meet with Babergh to get some clarity on what the sustainable level of growth of the village will be.

- **18.** <u>To discuss protocol for reporting absences from meetings from Councillors -</u> It was agreed to defer this item until it can be discussed with a full Council.
- 19. The Copse Decision on next Stage Cllr Spicer told the meeting that the Copse had been cleared Stage 1 funded by Babergh. The next stage is to make this area usable in the short term whilst we consult widely with School pupils, residents and Suffolk Rural -This is likely to take up to a year so are asking Bentley Parish Council to fund this work out of CIL funds as it would be wise to complete this work sooner than later so it does not return to a "new wilderness area" Following a short discussion it was proposed that £1,200 CIL money be made available for this project.

20. <u>Affordable Housing – Update –</u> Sunila Osborne – Housing Enabling Officer – Babergh contacted the Clerk suggesting a meeting to catch up where we are up to with the project and next stages etc. Clerk will arrange meeting with Councillors asap.

- **22.** Playing Field Society To confirm written agreement with Brantham Athletic The Agreement has not yet been signed need to confer with Cllr Bamford this will be done as soon as possible.
- 23. To discuss Suffolk Highways proposals re Not Suitable for HGV signs Cllr Munday told the meeting that she and a few Councillors attended an online presentation with Officers from Suffolk Highways and it was agreed that none of our roads were suitable for HGV traffic. Highways could not agree a weight restriction but felt Not Suitable for HGV signs were appropriate. However, things have now changed they are happy to put one at the A12 end of Bentley Hall Road and the A137 end of Church Road. They are proposing that we put signs on the A137 to warn any traffic that they should not be using Church Road if they are HGV's. We would be funding £3K for signs but the Brockley Wood applicant has agreed to put £20K towards weight restrictions on that road do we want to wait. Highways confirm that single track roads are unsuitable for HGV's. There should be better signage outside Folly Farm to restrict HGV's from using our village road. After some discussion it was agreed that we go back to Highways and say we don't want to go ahead with this we are not happy with their solution. We will continue to review.
